Form 990-EZ, Part II, Line 27	The net assets at the beginning of the year 2009 in the F990EZ for the tax year 2009 differ from the number filed in the F990EZ for the year 2008. The number filed today is correct (USD 3,482.-). I was informed on August 8, 2010 by our US bookkeeper that the number we filed in the F990EZ for the year 2008 (USD 2,665.-) was NOT correct, though.
